

Louise Suggs Junior Girls Invitational

Official Tournament Terms & Conditions

The Louise Suggs Junior Girls Invitational (the “Tournament”) is conducted by the Tournament Committee in partnership with Sunset Hills Country Club. By submitting an application and participating in the Tournament, the player and parent/legal guardian agree to the following:

1. Media & Publicity Release

The Tournament, Sunset Hills Country Club, and their respective representatives, sponsors, and media partners may photograph, film, livestream, and otherwise record the player’s participation in the Tournament. The player and parent/legal guardian grant the Tournament the right to use the player’s name, image, likeness, voice, hometown, school affiliation, and tournament results for promotional, marketing, sponsorship, historical, social media, website, broadcast, and related purposes, in connection with the Tournament, without compensation. This consent applies to current and future uses related to the Tournament and its promotion.

2. Championship Conduct Standards

The Tournament upholds the traditions and standards of championship golf. Players are expected to compete in accordance with the USGA Rules of Golf as adopted by the Tournament and to conduct themselves with integrity, sportsmanship, and respect toward fellow competitors, volunteers, officials, and the host club. The Tournament Committee reserves the right to impose penalties or disqualification for violations of the Rules of Golf, misconduct, abuse of property, or behavior deemed detrimental to the Tournament. All decisions of the Tournament Committee are final. Parents and spectators are expected to maintain appropriate conduct at all times.

3. Withdrawal & Entry Fee Policy

Acceptance into the Louise Suggs Junior Girls Invitational is by invitation only. Upon receipt of an invitation, a participant’s entry is confirmed only when full payment of the required entry fee is received by the Tournament. All entry fees are **non-refundable** once a participant has accepted the invitation and submitted payment. No refunds will be issued for withdrawal, cancellation, injury, illness, scheduling conflicts, travel disruptions, weather conditions, acts of God, or any other reason.

4. Weather & Schedule Modifications

The Tournament Committee reserves the right to adjust pairings, starting times, format, number of holes, or schedule due to weather, course conditions, or unforeseen circumstances. In the interest of safety and competitive fairness, all decisions of the Tournament Committee are final.

5. Assumption of Risk & Release of Liability

Participation in competitive golf and related activities involves inherent risks, including but not limited to injury from golf balls, clubs, weather conditions, and outdoor activities.

By participating, the player and parent/legal guardian knowingly and voluntarily assume all risks associated with participation in the Tournament. To the fullest extent permitted under Georgia law, the player and parent/legal guardian release and hold harmless the Tournament, its committee members, officers, volunteers, sponsors, representatives, and Sunset Hills Country Club from any claims, demands, damages, or liability arising out of or related to participation in the Tournament, except for claims resulting from gross negligence or willful misconduct.

6. Parental Consent

If the player is under the age of 18, a parent or legal guardian must complete the application and confirm acceptance of these Terms & Conditions on behalf of the player. Players who are 18 years of age may accept these Terms & Conditions on their own behalf.

By submitting an application, the player and parent/legal guardian acknowledges that they have read, understand, and agree to these Terms & Conditions.
